

Membership Fees

Members are only required to pay a **one-time fee** and enjoy **life long membership** with the PSDC. No monthly or annual fee is required!

FOUNDER MEMBERSHIP

The PSDC has 31 Founder Members. The membership was closed since 1990.

FULL MEMBERSHIP

Your privileges as a Full Member are as follows:-

- Be eligible to be elected to the Management Council of the Centre at its Annual General Meeting.
- Be eligible to nominate Founder or Full Members for election to the Management Council.
- Be eligible to one (1) vote at the Annual General Meeting.

Fee: RM 20,000 (irrespective number of employees)

ORDINARY MEMBERSHIP

Your privileges as an Ordinary Member are as follows:-

- Be eligible to nominate Founder or Full Member for election to the Management Council.
- Be eligible to one (1) vote at the Annual General Meeting.
- An Ordinary Member may apply to become a Full Member by paying the difference of the membership fee paid subject to decision of the Management Council as per Article 6(5)(e).

Fee :	Less than 500 employees	: RM5,000
	Between 500 - 1,499 employees	: RM10,000
	More than 1,500 employees	: RM15,000

Application Procedure

Membership Criteria

1. Opting for Holding Company Membership

An organisation may opt to apply for membership as a separate legal entity or as a group of company operating under the direct control of a parent holding company. The PSDC will only liaise with the parent holding company. The membership fee shall cover the number of employees of the separate legal entity or the group of related companies as the case may be.

Note:

The number of employees employed should include branches, as well as for subsidiaries of companies opting for holding company membership. It includes both management and non-management staff. Contractual labour is excluded.

2. The organization must be incorporated in Malaysia

3. Attachment Partners - Student Internship Program (S.I.P)

Members of the PSDC are required to provide 5 attachment and internship placements for final year PSDC students. The PSDC's S.I.P is arranged continuously so that member companies can benefit from an almost continual one-year period of student attachments. Member companies which have participated in the attachment programs have cited the following benefits;
